



Section 3 – External Auditor Report and Certificate 2020/21

In respect of **Chigwell Parish Council - EX0047**

1 Respective responsibilities of the body and the auditor

We are unable to complete our review work on the AGAR and supporting documentation as a result of correspondence received in relation to 2020/21 and/or prior years.
