- Double fees apply if a plot is purchased in advance (Purchase in Reserve).
- No charges apply where the deceased is under 18 years of age.
- Public Graves:** A burial in a grave owned and controlled by Chigwell Parish Council where no Exclusive Right of Burial is granted. Public Graves may accommodate more than one interment, including unrelated persons, and no right to erect a memorial exists. These graves are commonly used where burial arrangements are made by a local authority or Coroner, or where there is no known estate or next of kin available to make arrangements. As no Exclusive Right of Burial is granted, this charge is not directly comparable to the purchase of a private grave.
